GRANT APPLICATIONS - 14 DECEMBER 2016

1 Executive Summary

- 1.1 Thirteen applications have been received for Small Community Grants (Appendix A).
- 1.2 Small community grant awards are limited to £2,000 per application (September 2011 meeting decision).

2 Recommendation(s)

2.1 Members of the panel to agree which applications for small community grants meet the Council's priorities and criteria, and how much grant funding each should receive.

3 Financial Implication(s)

3.1 The 2016/17 budget for Small Community Grants is £20,025. At the first meeting in June the Grants Board awarded £8,000 meaning that there is a remaining budget of £12,025 for the 2016/17 financial year. The thirteen applications received amount to £21,940 which is £ 9,915 more than is available.
