1. APOLOGIES:

2. REVISED FEES FOR HACKNEY CARRIAGE AND PRIVATE HIRE LICENCES:

Report of the Director (Governance) asking the Council to consider and set fees for hackney carriage and private hire licences and to agree a date when these fees would come into effect.

The recommendation from the Environment Overview and Scrutiny Committee was to increase the fees by 20% once the statutory process of advertising had taken place. These fees had not been increased since June 2006. Officers outlined that this increase might result in a small surplus of around £10,000 on the account, but this was considered the most prudent approach in budgeting terms as it was important to ensure that the ring fenced account did not fall into a deficit position for the future.
