The effect of the modifications (*as indicated on the attached plan*) will be as follows:

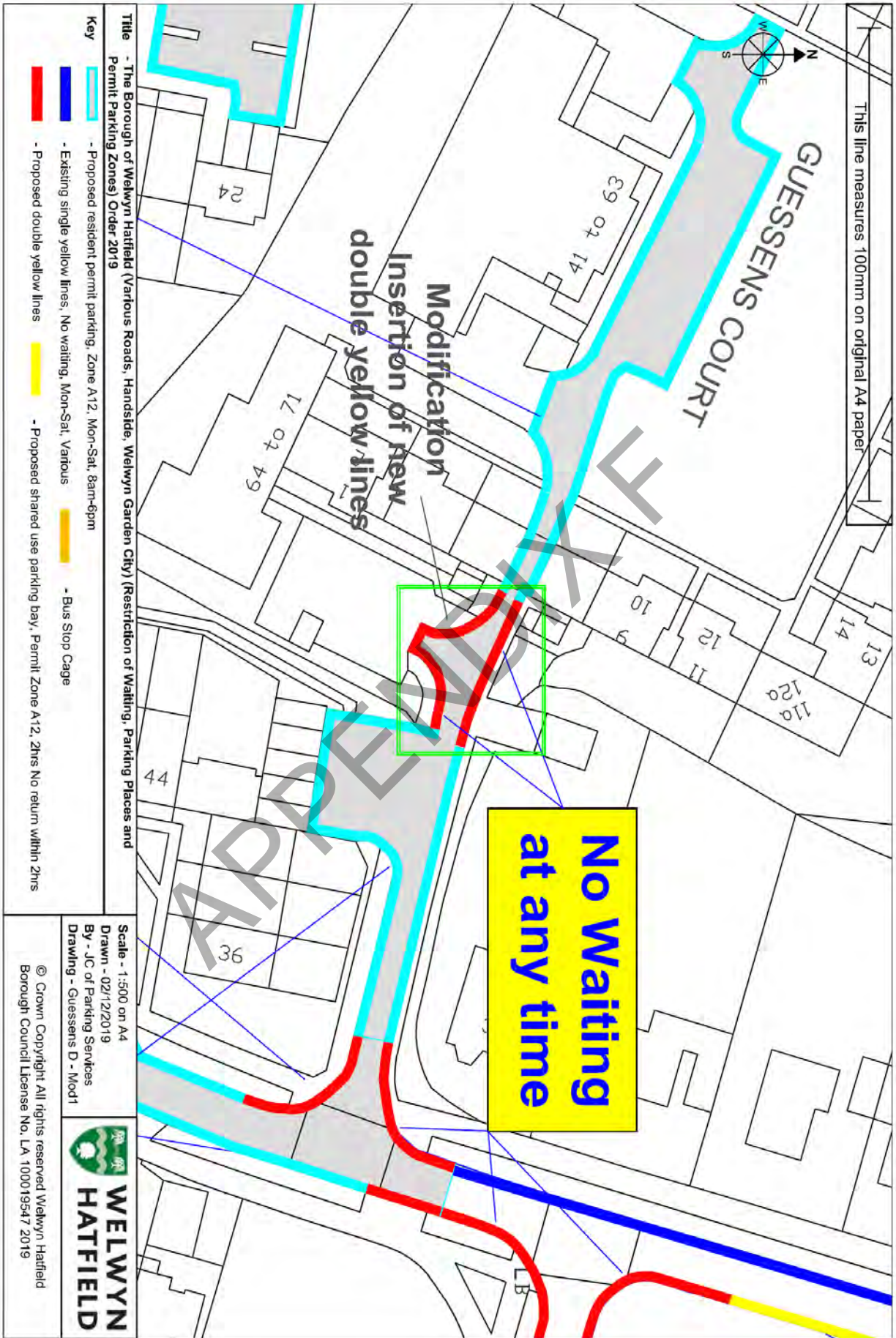
- The insertion of additional double yellow lines at the approach to the Archway.

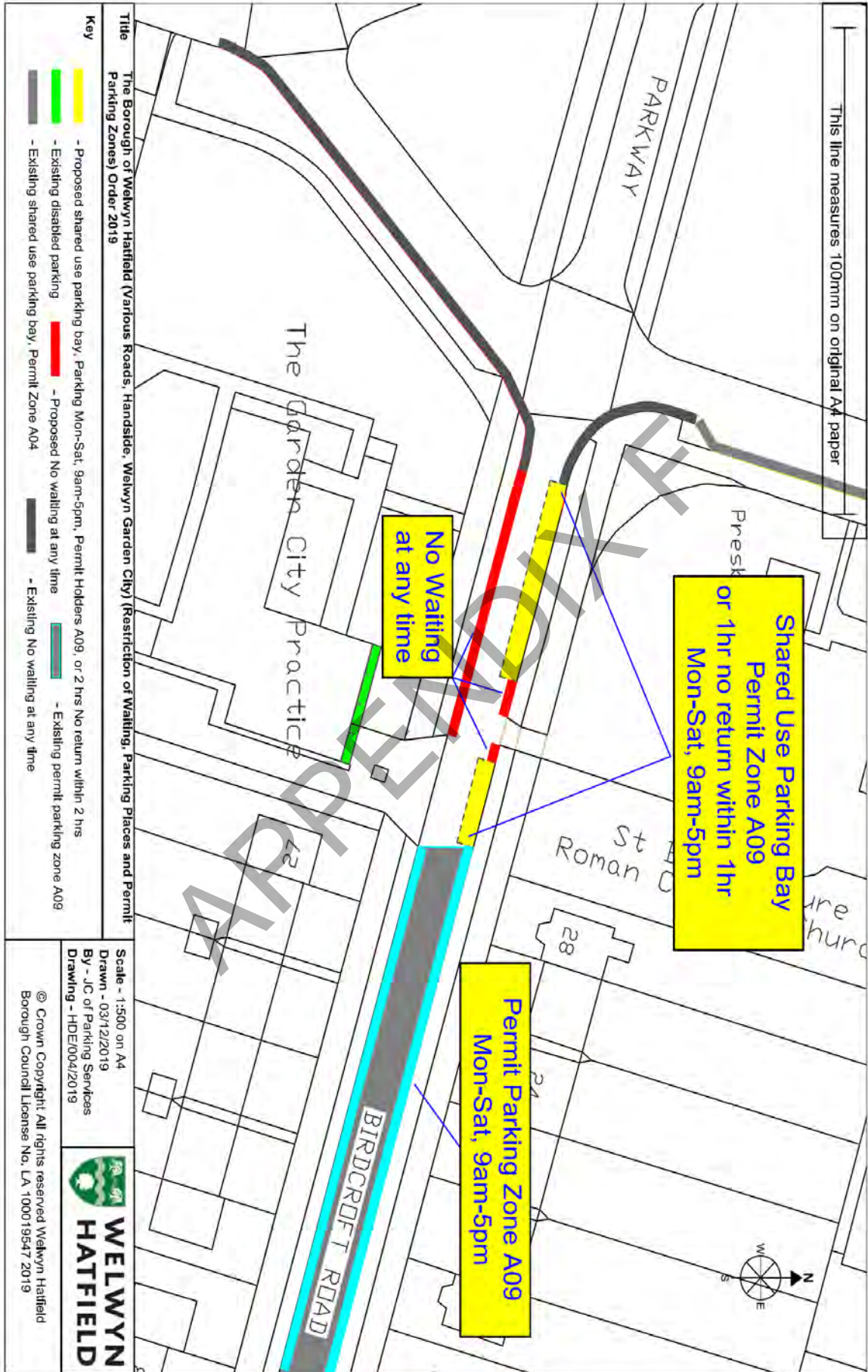
- To reduce the waiting period in the shared use parking bays from 2hrs to 1hr
