STATEMENT OF REASONS FOR PROPOSING

THE BOROUGH OF WELWYN HATFIELD (VARIOUS CAR PARKS, HATFIELD) (OFF-STREET PARKING PLACES) ORDER 2021

Welwyn Hatfield Borough Council is proposing to revoke parts of the existing off-street parking order and create a new off-street parking order for the following Hatfield car parks;

- **Kennelwood Lane**
- **Dog Kennel Lane**
- **The Common**

The new order will allow Parking Services to introduce restrictions in the newly built car park in The Common, as well as introduce new paid for parking in Dog Kennel Lane and Kennelwood Lane car parks.

In Dog Kennel Lane, to introduce paid for parking for season ticket holders. In Kennelwood Lane to introduce pay and display option to all parking bays. In The Common, pay and display parking spaces alongside paid for Disabled Bays, electric charging spaces and motorcycle parking.

Specific parking locations will be mapped out within the Order for parking bays which are designated for Blue Badge holders, motorcycles, pay and display.

Having considered the duty imposed by Section 122 Road Traffic Regulation Act 1984, it appears to Welwyn Hatfield Borough Council that it is necessary and expedient to make the Order for the following reasons:

- **To facilitate the passage on the road or any other road of any class of traffic including pedestrians**
- **To relieve or prevent congestion of traffic**
- **To provide suitable parking facilities**

All the above restrictions have been subject to consultation with car park users, local businesses, the Police, Hertfordshire County Council and Borough and County Councillors representing the area.
