6 EXPLANATION/BACKGROUND:

- 6.1 The council has the need for a competent organisation / individual to assist with the management of asbestos across its housing portfolio in compliance with The Control of Asbestos Regulations 2012
- 6.2 The scope of works includes;

- Asbestos compliance
- Asbestos surveys
- Out of Hours service with regard to asbestos management and remediation
- Asbestos incident investigation
- Delivering of training
- 6.3 The current contract expires on 30th November 2023. A new procurement has been undertaken to ensure service continuity.
- 6.4 Two bids have been received, however only one was considered to meet the minimum criteria. The reasons for the one bid not meting the minimum criteria is included in Appendix 1.
- 6.5 The bid from Brian Robinson met all the minimum criteria and has been evaluated to ensure it meets all the requirements.

- 6.2 <u>Financial Implications</u>:
