6 EXPLANATION/BACKGROUND:

- 6.1 The Council has three contracts in place to provide professional services to support the delivery of a number of new build construction and refurbishment projects.
- 6.2 The contracts have operated well with the companies providing a good service and help the delivery of a number of high-profile schemes (such as Cladding removal at Queensway House and the refurbishment of Knightsfield Flats).
- 6.3 The companies are also involved in a number of ongoing schemes and their continued involvement in these schemes is considered beneficial.
- 6.4 There is no further capacity to extend the contracts, so a new procurement will need to take place in about one year.

6.5 <u>Legal Implications</u>:

There is provision in the contracts to extend them by a further year, which will be compliant with Regulation 72 of the Public Contracts Regulations 2015.

6.6 <u>Financial Implications</u>:

The contract pricing is generally based on a percentage of the build / refurbishment costs and this pricing mechanism would continue in any extension of contract.

6.7 Risk Implications:

There are not considered to be any risk implications directly associated with extending these contracts.

- 6.8 Alternative options considered and reasons for their rejection (if any):
- 6.8.1 In house provision: rejected as it is considered that local authority pay scales not would attract the correct calibre of candidates.
- 6.8.2 Commence a new procurement rejected as it is not considered to be in the councils interest at this stage.
