To adequately and appropriately consult with those who are currently and would/could be affected by the control zone of the Hatfield PSPO's now and in the future. To understand the issues and concerns of those within the proposed control zones.

There is an understanding that the proposed control zones have a varied social demographic, in terms of residents and businesses, as such it is important that all those who could be affected are appropriately and adequately consulted prior to consideration being given to the implementation of those PSPOs.		
What consultation has taken place in the development or review of the policy, project or service?	The consultation will be undertaken between 7 February and 13 March 2024. There is a legal duty for the council to consult to ensure that the proposed PSPOs are proportionate and necessary within their geographical area. As part of the consultation, we plan to liaise with residents, organisations, visitors and businesses in Hatfield.

Age	YES	YES	NO	The PSPO will not discriminate in terms of age, however with regards to rough sleeping anyone under the age of 18 will be provided with accommodation through Herts Young Homeless, such provision is not automatically available to those over the age of 18. Therefore, the prohibitions in the proposed PSPO regarding rough sleeping, and to a point begging is more likely to affect those over the age of 18. However, we will support and signpost any individuals to sources of help so in this respect there is a possible impact through engagement with individuals.
Disability	YES	YES	NO	Disability can include mental health conditions. Research has shown that begging is commonly used to feed drug and alcohol misuse habits (and mental health issues may be associated with these addictions). Research has also found that often the persons begging are not homeless. There is no intention to target homeless persons under the begging provision. If enforcement officers find persons begging, or street drinking, that are vulnerable or in need of support appropriate action will be taken so there is a positive opportunity to engage and support people.
Ethnicity	YES	YES	NO	It is understood that there are a small number of rough sleepers are from a variety of ethnic backgrounds. A concerted effort will be made with local organisations, churches and other groups to ensure that these individuals, and those organisations that they are associated to, are consulted appropriately. It is accepted that language could be a barrier which is why it is

				important to engage with and utilise organisations, such as the Polish Forum, to assist in the delivery of this consultation. In particular, intelligence suggests that the large groups congregating at Hilltop inparticular are of Eastern European community. Engagement with them is taking place to speak with them about these issues.
