# 5 <u>EXPLANATION/BACKGROUND:</u>

- 5.1 Four council owned properties require extensions to facilitate independent living.
- 5.2 The work involves:

Knella Road - Rear single-story extension to enlarge kitchen and dining space. Lounge converted to bedroom. Addition of new accessible wet room and external ramp to garden.

Lamb Close - A single storey rear extension to enable a new ground floor double bedroom with ensuite wet room and external ramp to garden. Front entrance and hall extended for appropriate wheelchair level access. Existing doorways widened.

Hillcrest - Rear extension to include a bedroom and a bathroom

Sloansway - Rear single-story extension to enlarge kitchen. Lounge converted to bedroom. External ramp to garden.

- 5.3 A mini competition took place in accordance with the London Construction Programme's DPS for Minor works.
- 6.4 Only one bid from (ICB General Building and Civil Engineering Ltd) was received which was evaluated and considered to meet the requirements.
- 6.5 <u>Legal Implications</u>:
- 6.5.1 The use of the London Construction Programme DPS for Minor Works is in accordance with the Public Contracts Regulations 2015.
- 6.5.2 The Form of Contract will be an unamended JCT2016 Minor Building Works Contract.
