# WEWYN HATFIELD BOROUGH COUNCIL – MEMBERSHIP TO HERTFORDSHIRE CLIMATE AND SUSTAINABILITY PARTNERSHIP

# 1 Executive Summary

- 1.1 This report outlines the request for the Climate Biodiversity Cabinet Panel to approve the draw down of funds from the climate reserves to pay for Welwyn Hatfield Council's membership of the Hertfordshire Climate Change and Sustainability Partnership (HCCSP).
- 1.2 An overview of the benefits and importance of HCCSP is provided below.

#### 2 Recommendations

2.1 That the Climate Biodiversity Cabinet Panel approve the request to use money from the climate change earmarked reserve to pay for Welwyn Hatfield Council's membership of the HCCSP over the next three years.

#### 3.0 Explanation

- 3.1 As part of the climate emergency which WHBC declared in 2019, and in support of our pledge to be net zero as an organisation by 2030 and a borough by 2050, WHBC signed up to become members of the HCCSP.
- 3.2 HCCSP was established in 2020 as a partnership between the 10 districts and boroughs, County Council and the Local Enterprise Partnership (LEP).
- 3.3 The main remit is for partners to collaborate and identify joint work programmes on environmental, climate change and wider sustainability issues.
- 3.4 HCCSP has member representation which meet every 6 weeks to discuss and approve initiatives.
- 3.5 A subsidiary group of HCCSP is the Hertfordshire Sustainability Officers Group (HSOG) that meet every 6 weeks in between HCCSP meetings. During these meetings officers share and explore ideas of collaborative work programmes and initiatives.

- 3.6 There are 6 sub-groups of HCCSP, namely, Adaptation, behavioural change, biodiversity, carbon, transport and water. They each have individual strategic action plans.
- 3.7 The membership fee has historically come from the climate reserves, however we wanted to formalise this moving forward.
- 3.8 The subscription fee for the next three years (2024/25, 2025/26 and 2027/28) each year is £9,735.
- 3.9 Benefits to be members of HCCSP include;
  - Saving of officer time to implement projects; sharing comms, templates, guidance etc.
  - Financial savings as a result of the collaborative approach and sharing of costs.
  - Sharing of ideas and opportunities.
  - Broader impact, as projects span the whole county not just districts and boroughs.
  - Collaborative approach means we do not miss out on opportunities that we could not take advantage of on our own.
  - o Aligned goals across the county ensures we are all working collectively.

- 5.1 The total cost of the three-year subscription will be £29,205, to be funded from the Climate Change Earmarked Reserve.
- 5.2 An additional top up of £50k was made to the climate change earmarked reserve as part of the 2023/24 out-turn, which exceeds the cost of membership for three years and the balance will be able to be utilised for wider activities and projects to support the climate change priority.
- 5.3 As set out in the council's medium term financial strategy, the Climate Change Panel has delegated authority to approve the use of this earmarked reserve in consultation with the Council's S151 Officer. The S151 Officer has been consulted and input into this report.

### 6. Risk Management Implications

6.1 There would be a risk if the climate reserves could not fund the membership of HCCSP and provide future budget for future years. WHBC would miss opportunities of joint work programmes, which often save officer time and cost.
