

## Addendum to Cabinet 4 April 2017 and Council 10 April 2017

### Introduction

Appendix A to Item 7 at the 16 March 2017 meeting of the Cabinet Housing and Planning Panel set out summaries of the main issues raised by consultees at the recent Draft Local Plan Proposed Submission consultation. Since that time a respondent has identified that one of their three representations was not summarised in Appendix A and does not appear on the online consultation portal.

### Explanation

All three of the respondent's representations were duly made within the consultation period, and the missing representation has now been added to the portal. Because it was a comment on the Policies Map (Sheet 3), it has been given reference PSPM768.

Comment PSPM768 seeks a similar change to another of the respondents' representations (DLPPS1729), on Policy SADM10 *Employment Development*. This was summarised and reported at the 16 March 2017 meeting on p195 of the agenda (Appendix A3) as below:

Because PSPM768 seeks broadly the same change as DLPPS1729, the 'WHBC response' in Appendix A would have been the same. The recommendation to CHPP would therefore not have altered, and it is not considered that the respondent has been disadvantaged. However, it is considered appropriate and necessary to include

the omitted representation and the response to it in the summary of main issues for Policies Map Sheet 3 (page 477, Appendix A5), in the manner shown below:
