I am making an objection to the notice advertised on 15th November 2017 titled "The Borough of Welwyn Hatfield (Various Roads, Welham Green) (Restriction of Waiting) Order 2017.

From your letter of 20th October, it looks like the double yellow line will extend alongside our property to up to our kitchen at [REDACTED] Nash Close. We don't want the line to extend that far because we need to be able to comfortably park 3 cars along the side of our property extending up to our garden fence.

Therefore, we need the double yellow line to stop exactly at the drain grill in the road (please see my picture attached). By ending the double yellow lines here, we will be able to park 3 cars properly. We have 2 cars and any of our neighbours will be able to park in the 3rd spot.

I am making an objection to the notice advertised on 15th November as per the above mentioned details.

I had originally made my situation clear in my email to you dated 5th February 2017 (copy attached) and subsequently understood from your interim letter dated 15th June 2017 that there were no plans to implement extended double yellow lines at the junction in to our part of the close. Therefore I was concerned that you had retracked on your original findings and that 4 residents had now wished for fuller double yellow lines to be advocated which would mean that my house would potentially be directly affected.

I acknowledge that at the turning head there would be some justification for shorter double yellow lines but cannot see any reason to extend any further and to cover the entire space outside my house. I have had the use of this convenient space over many years and know that this area and formerly the space on the opposite side of the road were popular with residents to park their vehicles before double yellow lines were previously initiated.

Also I note that 4 residents have requested this action and means in reality that the remaining 8 residents in this section of the close would have totally no objection and does not represent a valid quorum or representation of the parking issues.

If it were considered a necessity then I have previously enquired about erecting a dropped curb and also for the council to remove the tree at the front of the garden that they had planted to enable landscaping of that area to be possible.
