WEWYN HATFIELD BOROUGH COUNCIL - CLIMATE CHANGE UPDATE REPORT

1 **Executive Summary**

1.1 This report outlines progress being made regarding WHC's corporate priority on 'Action on Climate'.

2 Recommendations

- 2.1 Members note the progress of specific projects/actions within the Climate Action Plan, which is the main tool used to monitor our pathway to net zero as an organisation (2030) and as a borough (2050) and note the wider co benefits of such actions.
- That we publish the recently corporate (2023/24) and borough (2022) carbon footprints on our council websites.

3.0 **Explanation**

3.1 It is important to monitor progress as we transition to net zero. Key updates against the Councils' action plan are as follows;

Actions 86 and 88 – In relation to general decarbonisation work of commercial portfolio

 Hatfield leisure centre had its inefficient sports hall lighting changed to LED's. This project is set to result in an 84% reduction in running costs, save 14.7 tonnes CO2 annually moving forwards, and the payback period is just 1.35 years.

Action 54 - In relation to LEVI (Local Electric Vehicle Infrastructure funding)

 The parking team I continue to work with HCC to implement the LEVI funding. We are awaiting the Partnership Agreement in order to proceed to the next stage.

Action 3 – In relation to funding opportunities

- We have been awarded £20,000 by the National Lottery Community Fund to install some energy generating outdoor gym equipment.
- Herts Sports & Physical Activity Partnership partnered with Funding4Sport – a specialist sport and physical bid writing service.
- We had to provide an idea that encouraged people to be more active, whilst also improving the environment.
- The location will be King George V playing fields. We hope to install three pieces of equipment, new surfacing and a display board to explain about the renewable energy being generated.
- Users will be able to charge up their phones, tables etc

Action 90 - In relation to ISO 50001 accreditation

- We are in the final stages of writing the documentation which establishes the energy management system.
- The documents define the scope and boundary, internal processes, internal monitoring schedule, training and energy policy.

Classification: Unrestricted

- Once completed, the system will be audited and verified externally, and certification will hopefully be awarded.
- o ISO 50001 will help us monitor energy use across our portfolio, it will flag anomalies in a timely manner, ensure we fix any issues that arise, identify buildings that are not performing optimally, and highlight areas that can be improved. It will ultimately keep us on track to making significant energy reduction as we transition to net zero.

Action 97 – In relation to the Transition to Net Zero Strategy

 The strategy is out for public consultation (so please do share link with constituents as we value everyone's feedback).

Action 34 – In relation to implementing statutory obligations (nature and biodiversity)

- Local Nature Recovery Strategy will answer three questions about nature recovery; What can we do? How can we do it? Where can we do it?
- HCC are currently running engagement session to identify potential sites for the creation or restoration of habitats. They are seeking help on determining sites of importance for nature, ongoing/proposed nature projects and pressures and priorities within Hertfordshire.
- Within the initial engagement period, HCC have hosted 5 in person events around Hertfordshire and two virtual events.
- They have scheduled two more engagement periods which will run September and October and then November and December.

Action 91 – In relation to emissions reporting

- As per another item on the agenda, we have recently received up to date emissions reporting from Team Energy (our energy management consultant who hosts, our energy monitoring platform and conducts annual greenhouse gas assessments).
- We request that we publish the corporate and borough carbon footprints on our council websites.
- Making this information publicly available demonstrates our continued efforts in reaching our net zero targets and ensures we are being robust and transparent on our pathway.

Action 5 - Seek and promote schemes around the borough such as Home Upgrade Grant (HUG2), Solar together, ECO flex 4/BGIS, BHBH

- We have signed up to support the delivery of <u>Home Energy Retrofit</u> <u>Options (HERO) Plans.</u> They are being offered to Hertfordshire residents for a limited time, by the National Energy Foundation.
- The scheme provides homeowners the opportunity to learn and understand how they can maximise the energy efficiency of their home, achieve greater comfort, cost savings and reduce their carbon footprint.
- A_qualified Retrofit Consultant will conduct a home survey and create a bespoke HERO Plan, which will provide independent advice on retrofit measures.
- O Homes are being prioritised that are 'difficult to retrofit and are 150m2 or less', for instance listed buildings, poorly insulated homes, homes within conservations areas or have solid walls. However, there is other eligibility routes, so residents are urged to contact https://superhomes.org.uk/beds-herts/ or to call 01908 699991, to see if they can take up this fantastic, limited time opportunity.
- We have promoted this via social media, targeted emails, a press release and NEF have also sent direct mail out to certain homes.
- We have signed up to support and promote the <u>"Let's Go Zero" Climate Action Advisors campaign.</u> The advisors will attend the education setting and provide free tailored advice to help 'green' England's school buildings, transport, menus and more by creating their own climate action plan.
- The service provides an excellent opportunity for education providers to receive expert, bespoke advice on how to become net zero, guidance on best practise and signposting to funding and resources.
- WHBC are supporting and promoting this initiative on our Climate Hub and though social media posts. We have also sent an email to all schools in the borough.
