8. MINUTES OF LAST MEETING

9. DECLARATIONS OF INTEREST

10. METHODOLOGY & REVIEW OF TICKETS ISSUED

Eliska Robova (Parking & Playground Services Manager) and Geoff Sampson (Assistant Director Regen & EconDev) took the Group through the presentation, the following were the key points taken:

 Part 6 of TMA 2024 provided a single framework for civil enforcement by local authorities. Civil Parking Officers cannot exercise any discretions. Any disputes (PCN) are processed by back-office staff in line with legislation.

TROs/Parking Permits Task & Finish 27 January 2025

PCN Charges are set by legislation. High level PCN issued are set at £70 whereas lower-level ones are set at £50. The statutory process sets out how penalties are being issued and the process.

PCN Stage

A PCN is issued at either £50 or £70 depending on its level, this amount can be discounted by 50% if it is paid within 14 days. The recipient can make an informal challenge.

Notice to owner stage.

28 days from the original issue date a notice to the owner is issued. A formal representation to the council can be made.

Representation stage

Dependant on the outcome of the representation you will be issued a notice of acceptance or rejection.

Appeal stage

An independent adjudicator at traffic penalty tribunal reviews the issued PCN.

• Charge certificate stage.

After 35 days from the notice to owner stage (63 days after date PCN was first issued), the PCN increases by 50% (£75 or £105).

Order for recovery stage

If after 14 days from the charge certificate stage the PCN remains unpaid, it will be increased by £10 to £85 or £115.

Why has Welwyn Hatfield asked East Herts to carry out civil parking enforcement on their behalf.

They have asked for this as there are 3 councils that are signed to the same contract and East Herts manages that, it also worked out more expensive to be independent.

11. <u>INCOME AND EXPENDITURE FIGURES</u>

Eliska Robova (Parking & Playground Services Manager) then took the Group through the income and expenditure table and the key points noted are as follows:

TROs/Parking Permits Task & Finish 27 January 2025

- Income holds two streams, permit income, and penalty charge notice income. Their overall difference was £327,640 since 2022/23.
- Costs hold more outgoings, these are contract cost, officer time, recharges from other areas, recharges from other services, signs and lines and advertising. Their overall difference was £137,478 since 2022/23.

The overall position is £100,494 and has seen a £10,826 increase since 2022/23.
