Making decisions about any matter in the discharge of an executive function which is not within the budget or policy framework, unless the decision is urgent within the meaning set out in the Budget and Policy Framework Procedure Rules in Part 4 of the Council's Constitution.</li> <li>4. Appointing the Leader, Mayor and Deputy Mayor of the Council.</li> <li>5. Receiving an annual report from the Overview and Scrutiny Committee in relation to its work.</li> <li>6. Agreeing and/or amending the terms of reference for Committees, exercising non-executive functions, deciding on their composition and making appointments to them.</li> <li>7. Promoting and maintaining high standards of conduct by Members and Co-Opted Members of the authority.</li> <li>2. Advising and assisting Town and Parish Councils and Councillors to maintain high standards of conduct and to make recommendation to Town and Parish Councils on improving standards or actions following a finding of a failure to comply with the Code of Conduct by a Town or Parish Councillor.</li> <li>3. To progress complaints on behalf of Town and Parish Councils.
